Brief Course Description

Definition and description of child exceptionality and psychopathology; theory and research in etiology, educational implications, and treatment.

Course Objectives

To give each student a general overview of child psychopathology and exceptionality: including definition, description, etiology, theory, research, educational implications, and treatment. To enhance each student's understanding of emotionally and behaviorally disordered children and their special needs.

Instructor

Dr. Rosén is a Psychology Professor at Colorado State University and past Director of the Psychological Services Center at Colorado State University. He received his doctorate in Clinical Psychology from the State University of New York at Stony Brook in 1984 and completed his Residency in Clinical Psychology at the University of Mississippi Medical Center. He has several research publications and professional presentations. At Colorado State University, Dr. Rosén teaches undergraduate and graduate level courses in Clinical and Counseling Psychology, Child Exceptionality and Psychopathology, Child and Adolescent Therapy, Consultation, and Advanced Clinical Practicum.

Course Requirements

Each student will be required to take **three** examinations and satisfactorily complete **three** papers.

Examinations (100 points each)

There will be three examinations. Each exam will contain several short answer essay questions. Each exam will concentrate on material (lectures and chapters in text) since the last exam and may also cover a small amount of material from the previous section(s). ***All exams will be "open book" – notebook, and text. You will be required to complete each exam online through Canvas, within the time and dates specified by the instructor.*** You will write at least one essay for each chapter that you are being tested on - you will pick from a number of questions that reflect the content of that chapter. These are questions that will provoke your thinking and don't have right or wrong answers. I will be wanting you to write a couple (**at least two**) short paragraphs for each short answer essay. And, it will be important that you cite information from the textbook and/or lectures in your answer. The required tests have time limits - 240 minutes (four hours) for each exam. Exam grades will be posted on ***Canvas***.

Short Papers

Three short papers (each a minimum of 500 words) will be required of all students. The purpose of these papers is to expand your thinking on the topics, to make the principles of child psychopathology more relevant to your own life, and to encourage exploration of the research literature. These projects were developed to enrich your experience in this course. I hope they will help you learn more about your own childhood, allow you to apply textbook principles in real-life situations, and expand your knowledge of favored topics in child psychopathology. Please be aware of due dates. Late papers will receive an automatic 5-point deduction. ***Papers will be submitted through Canvas.***

Paper #1: Childhood Experience (30 points)

Describe an incident or experience that affected you as a child/adolescent. Give examples of your behaviors and emotions and indicate how they may have developed. (**Note: If you choose to reveal an incident of child abuse or neglect please be aware that I am a mandatory reporter – meaning that I may be required to report the maltreatment to Child Protective Services.) Relate your description to information presented in text, lecture, or supplementary readings. Minimum length = 500 words.

Paper #2: Book/movie/play Report (35 points)

Write a short synopsis and your reactions to a book (fiction or non-fiction), movie, TV show, or play about children, adolescents, childhood, or families. Tell how the book/movie/TV Show/play helped you better understand the factors that are influential during childhood. Relate your discussion to what you are learning in this course. Minimum length = 500 words.

Paper #3: Research Paper (35 points)

Write on a topic of your choice -- anything relating to the general area of exceptional children or child psychopathology. Your discussion and conclusions should be based on current research. Cite at least three (3) references - give a reference list. Minimum length = 500 words.

Your performance on the three **exams** and three **papers**, will determine your grade. The points will be totaled as follows:
